The approval is subject to the following conditions:-

1. The above Purchase Rate as per Column No 3 shall be SICOP Purchase Rate from SSI Units and is inclusive of applicable GST of the item but exclusive of SICOP Service & Testing Charges @ 6.25% and shall be Ex Works.

2. The above Sale Rate as per Column no 4 shall be SICOP Selling rate to the Department but inclusive of 6.25% SICOP service & testing charges & also, GST @ 18 % on SICOP Service & Testing Charges @ 6.25% and shall be Ex Works.
3. The rate shall remain firm for the F.Y. 2020-21 and however, only subject to change as per GST rules.
4. The Marketing Wing shall identify the quantity and intimate the sale rate to the intending department and also, to verify the availability of funds of particular supply order with the intending department. Moreover, atleast 20% on account payment may be released from the intending department while receiving supply order from them.
5. The Testing Centre shall ensure adherence of the prescribed quality parameters.
6. In cases where the transportation is not possible by road at site, the head load shall be allowed and charges paid according to the norms fixed by the PWD in this respect.
